

## Blacktown & Districts Soccer Football Association Incorporated **Registration Regulations**

## **REGISTRATION OF PLAYER'S**

- 1. The BDSFA Inc has adopted the FFA National Registration Regulations and all below must be read in concert with those regulations.
- 2. Any person wishing to play in any game conducted by the BDSFA Inc. must first be a member of an Affiliated Club and must be a duly registered player with the Association.
- 3. A person cannot register for two clubs/associations without first being transferred and/or cleared to register.
- 4. A person may transfer once per season.
- 5. Players must register using FFA www.myfootballClub.com.au web site.
- 6. A person is not registered until such time an Affiliated Club accepts the registration.
- 7. All registering players must ensure the photograph on MFC is up to date and is a clear
- 8. In all cases, if a player no longer resembles his photograph a new photograph must be uploaded and the Club and Association informed.
- 9. All players must produce 100 points proof of identity to their Club.
- 10. The onus is on the Club to verify the date of birth and identity of all players. Any such Club subsequently found guilty of supplying the Association with false or misleading information may be fined \$500.00.
- 11. No player will be registered unless he attains the minimum age of five (5) years old by the 31<sup>st</sup> December of that year in which he registers.
- 12. Any person Under the Age of 21 who is registered to play All Age, may not return to their correct age group without first supplying proof of birth as per above.
- For Age Groups designated as "Under" the Age of a player as at the 31<sup>st</sup> December the year 13. in which he registers shall determine the age group in which he plays.
- 14. For Age Groups designated as "Over" the Age of a player as at the 1st January in the year in which he registers shall determine the age group in which he plays.
- 15. Registrations will not be accepted within seven (7) days prior to the first official match.
- 16. All other registrations must be in the hands of the Registrar not later than 7 days prior to the first game in which the person plays.
- 17. Players serving suspensions in "matches" must register to serve their suspension.
- 18. Players serving suspensions in "time" may register once that "time" is served.
- 19. Persons under suspension or disqualification from another Association, Federation or Club shall not be accepted for registration until cleared by that body.
- All players must register under their current name, except in circumstances set down by the 20.
- 21. All registrations must be authorised by the Association.
- Any Club or person proved to be poaching a registered player will be dealt with by the Board 22. at their discretion.
- All registrations, transfers and player re-grades will cease on 30<sup>th</sup> June each season. 23.

## 2. **REGISTRATIONS OF OFFICIALS, COACHES and MANAGERS**

- 1. Any person wishing to work with Children within the Association must be aware of and meet the criteria set down by the NSW State Government for Working with Children.
- 2. All persons performing a duty that may come within the Working with Children legislation must comply with the requisites of the Law.
- 3. FNSW Member Protection Declaration must be completed annually and kept in a secure place for period of three years from date of signing and must be available for random checking.

- 4. Officials, Coaches and Managers must read, understand and sign the relevant code of behaviour for their role
- 5. Any person wishing to coach any team within the BDSFA Inc must be accredited as per the FFA Coaching Accreditation Scheme. The Board may agree upon a date during the season for persons to meet these requirements
- 6. Coaches and Managers must register using the FFA www.myfootballclub.com.au web site.
- 7. The "Required Details" must be provided when registering.
- 8. A current photograph must be uploaded during the registration process.
- 9. An ID card will be issued and must be visible at all times during a match.
- 10. Lost ID Cards must be replaced immediately at the Club's expense
- 11. Officials serving suspensions in "matches" must register to serve their suspension.
- 12. Officials serving suspensions in "time" may register once that "time" is served.
- 13. Persons under suspension or disqualification from another Association, Federation or Club shall not be accepted for registration until cleared by that body.
- 14. All persons shall register under their own names except in circumstance set down by the Board.
- 15. A registration fee shall be set at the discretion of the Board.
- 16. Coaches are responsible for the upkeep of their accreditation.
- 17. For all Female Teams, one team official must be female and must be present at all times. Male Officials are not permitted to enter the dressing room alone and not without the express permission of the female official.
